He said that the nutrient neutrality for the development has now been approved by Natural England. He also said that the existing bungalow will have a new approved treatment plant and that the proposed new build will also have its own approved treatment plant.

Planning Applications

112.23 6/2021/0262 Withy Lakes – Erect detached self-build rural exception site building.

Cllr Parker said that Natural England had not considered the composting toilets for Corfe Valley Learning and the septic tank from the previous stable conversion when assessing the nitrate and nutrient impact of the development. This should be communicated to both Natural England and the planning committee.

Cllr Brookes (Dorset Council) said that Natural England would have taken this into account and they supported the application.

Cllr Pitcher noted that the proposed new treatment plants will improve the nitrate and nutrient impact from the property by over 50% which should be regarded as a positive outcome.

The Chairman proposed the motion that <u>The Church Knowle Parish Council will not send a representative to object to the application to the Planning Committee meeting on Wednesday 5th April</u>
