APOLOGIES FOR ABSENCE

001.25 Apologies for non-attendance were received from Cllrs Carl Grice and Ian Gilbert.

DECLARATIONS OF INTEREST OF MEMBERS OF THE PARISH COUNCIL

002.25 It was established that no-one was recording the meeting. There were no declarations of interest by members of the Council.

PUBLIC DISCUSSION PERIOD

- 003.25 The damage done by offroad vehicles to the public rights of way at Cucknowle and along the hill tops has concerned the council previously (148.24, 174.24). Mr Edwards reported that the problem was continuing and that the damage done, in wet weather particularly, is leading to these tracks becoming impassable. These unmade up roads have designations D52004 and D50604 and are subject to the Highways Acts. It is possible to put a statutory restriction by way of a TRO (Traffic Regulation Order) on these tracks and this possibility, with other solutions, will be investigated with Dorset Highways.
- 004.25 The Council agreed that this is a serious problem causing permanent damage to an environmental asset within this Area of Outstanding Natural Beauty. Discussion of this will be a specific item on the February agenda. This will be advertised in the Corfe Valley News to invite members of the parish to attend, participate and help investigate possible solutions.

VACANCIES FOR PARISH COUNCILLORS AND CO-OPTION OF NEW MEMBER

005.25 There have been no new applications to join the Parish Council and the one remaining vacancy will continued to be advertised as usual.

MINUTES OF PARISH COUNCIL MEETING HELD ON 10th DECEMBER 2024

006.25 The minutes which had previously been circulated were read.

It was resolved that the minutes be accepted as a true record of the meeting. Proposed by Cllr Wilson, seconded by Cllr Newns and passed unanimously.

MATTERS ARISING FROM THE MINUTES OF THE DECEMBER MEETING

007.25 There were none arising from the minutes of the previous meeting.

THE NEIGHBOURHOOD PLAN

- 008.25 Cllr Newns reported that the Neighbourhood Plan steering committee had not held a meeting since the Christmas break..
- 009.25 Cllr Parker expressed a concern that all of the available funds were being spent on a consultant and that there would be no funds available to complete the process. The possibility of applying to the National Lottery and the Dorset Council for funding was discussed.

REPORT FROM THE DORSET COUNCILLOR

- 010.25 Cllr Ben Wilson said that the main item of interest in Purbeck was the Ferry enquiry that is scheduled for 21st January in Poole.
- 011.25 The Dorset Council budget has been approved by the full council and includes a 4.99% council tax increase.
- 012.25 The replacement and resizing of the highway storm water drain at East Creech is on the list of works required but is not a priority. The council expressed disatisfaction and will continue to lobby Glen Hallam of Dorset Highways

PLANNING MATTERS

013.25 There were no new Planning Applications.

HIGHWAYS MATTERS

015.25 The Council fully supports the campaign to prevent the damage being done by offroaders to the historic public rights of way along the top of the Church Knowle hills. This will be done in collaboration with Dorset Highways who are are authority in this matter.

THE CORFE RIVER

016.25 Cllr Newns (Planning and Environment) reported that Wessex Water had not had their proposed business case and budget approved by OFWAT. In the event of the WW capital budget being cut we will make direct representations to ensure that the local work remains a high priority.

017.25 No new applications.

- 023.25 The Parish is pleased to welcome a new baby born to the family who have recently moved into the parish.
- 024.25 Cllr Wilson reported that she has often encountered unmanned vehicular railway crossing gates negligently left open. There is a £1000 fine for leaving these gates open. Apart from the obvious danger, this represents a real hazard to animals who can wander down the track. It was agreed that the need to keep these gates closed would be included in the Parish Council's report in the Corfe Valley News.
